In mid-2019, several community and organizational leaders asked Erie Together, our region’s countywide anti-poverty movement, to help stakeholders create a comprehensive domestic violence reduction strategy for Erie County. Participating stakeholders include law enforcement, the District Attorney, domestic violence agencies, higher education institutions, various social service agencies, legal service providers, immigrant services, public health, healthcare providers, and others. The group began meeting in August 2019 and is now known as the "Domestic Violence Action Alliance (DVAA)."

One of the tasks before the DVAA was to identify specific challenges associated with reducing domestic violence in Erie County, and ways to address those challenges. The group defines “domestic violence” as “the use of physical, emotional, psychological or sexual abuse or stalking to gain or maintain power and control over an intimate partner, former intimate partner, or family member whether they live together or not.” One of the top challenges the group identified to reducing domestic violence was ***a need for improved interagency collaboration and communication to strengthen referrals and promote increasingly positive service outcomes.***

An important piece of this is the following **Resource Directory**, created to make it easier for organizations to understand relevant services provided across Erie County, know how those services can be reached, and make effective referrals. The following pages reflect those services provided by participating DVAA members from which domestic violence victims and/or family members could benefit.

***Special Message from SafeNet and Safe Journey, Pennsylvania Coalition Against Domestic Violence (PCADV) Members:***

Victims of domestic violence in Erie County deserve the most comprehensive trauma-informed services possible. Lives are at stake. In 2018 Erie County reported nine domestic-violence-related homicides. None of those victims had received prior support for domestic violence to keep them safe. We believe those tragedies may have been prevented if those victims had received the appropriate services from professionals trained in the realities of domestic violence. Many more victims live in our communities whose lives are being destroyed — threatened — by violent abusers.

It's essential for the safety of victims and their families that the first referral for any victim of domestic violence in Erie County be to Safe Journey, which serves the rural county, or to SafeNet, which is based in the city of Erie. Together, Safe Journey and SafeNet have a combined 90 years of organizational experience dealing with all aspects of domestic violence. We are the experts in the field of domestic violence advocacy in Erie County.

Safe Journey and SafeNet have the highest level of confidentiality under statute 23 Pa. C.S.A. § 6101, the Protection from Abuse Act. This act provides for absolute confidentiality between a victim and a certified domestic violence agency to encourage open and honest dialogue and assure safety.

Safe Journey and SafeNet are member agencies of the Pennsylvania Coalition Against Domestic Violence (PCADV). As members of PCADV, both agencies are monitored for compliance with state policies and all staff are certified in domestic violence. We also have experienced legal representation, and staff members receive up-to-date training in domestic violence advocacy.

Within this directory are many agencies that provide valuable resources for Erie County residents. Safe Journey and SafeNet take full advantage of that expertise by making a minimum of eight referrals for each victim served.

The safety of victims must always be the first priority. Safe Journey and SafeNet provide comprehensive and holistic support for victims and network with other organizations to meet the many needs of victims.

Programs include, but are not limited to:

## **Intimate Partner Violence 101**

This overview of IPV examines the dynamics of abusive relationships, types of abuse, red flags, long-term health effects, why some victims stay, and the services SafeNet offers to IPV victims.

## **Healthy vs. Unhealthy Relationships**

Teens will learn the difference between healthy and unhealthy relationships. This training includes ways to recognize signs of abuse, prevention of date violence, bullying and cyberbullying, stalking, and how to ask for help.

## **IPV on Campus**

One of the largest demographic for individuals experiencing physical, emotional, and sexual abuse in relationships is women aged 18-24. Learn the IPV risks prevalent on campus, healthy and unhealthy relationships, types of dating violence, red flags of abuse, bystander action, online safety, and stalking. Abuse/Neglect of Individuals Who Rely on the Care of Others When individuals must rely on the care of others to age or abilities, they are vulnerable to abuse. Their need for personal care becomes a barrier for disclosure and intervention. (Can be adapted for elder abuse or disability abuse.)

## **What Is Human Trafficking?**

Examine definitions, statistics, and case studies of human trafficking as well as the effects of trauma, legal implications, and IPV services for

victims. IPV Education and Prevention While IPV is caused by the abuser's need for power and control, there are steps that can help prevent it. Community outreach and education programs explore red flags of abuse, types of abuse, healthy and unhealthy relationships, safety planning, stalking, bullying, and bystander intervention.

### **LGBTQ: IPV Does Not Discriminate**

With IPV rates similar to those in same sex relationships, LGBTQ+ victims often face additional barriers to reporting abuse, seeking medical attention, and accessing IPV services. Cultural Barriers to IPV Education and Intervention Language, culture, religious beliefs, legal status, and fear of deportation can affect a victim's decisions to seek medical care or IPV services. This training helps friends, neighbors, and coworkers remain sensitive to cultural factors while offering assistance and referrals. Recognizing Signs of Trauma IPV can result in diminished cognitive and emotional processing, erratic social behaviors, sleeping or eating disorders, and substance abuse. Instead of treating the behaviors alone, these conditions must be recognized as trauma and addressed with IPV counseling support and trauma-informed services.

### **When Home Isn't a Safe Place: Effects of IPV on Children**

Children experience physical and emotional trauma from witnessing IPV in the home. These consequences can be long-term, affecting their success in school and their ability to form healthy relationships as adults. The High Cost of IPV IPV also carries a staggering price tag. Statistics document the high cost of IPV from financial abuse, medical care costs, lost wages, chronic health conditions, and the lasting effects on the next generation.

### **BARS in Bars**

Alcohol doesn't cause IPV, yet there is a connection between alcohol/drug use and IPV. This training is aimed restaurant/bar staff so they can recognize signs, defuse situations, and provide referrals.

### **IPV in the Workplace The effects of IPV often follow the victim to work**

Know the signs that a coworker or employee could be experiencing IPV and understand potential health, safety, productivity, supervisory, and financial implications. Workplace harassment and safety planning will also be discussed.

*SafeNet's medical program provides outreach and training in hospitals, medical offices, and colleges and universities.*

Training programs include, but are not limited to the following:

### **Medical Advocacy: IPV Screening in Medical Settings**

Healthcare providers play a vital role in starting the IPV conversation. IPV screenings in medical settings offer victims a safe place to reveal the

abuse, which in turn helps providers make effective treatment decisions and referrals for IPV services. Screenings can save lives and relieve the trauma of children witnessing abuse at home. In addition to emergency medical facilities, practices with an increased likelihood of seeing IPV victims include OB-GYN, pediatric, primary care, mental health, dental, and orthopedic offices. When a victim screens positive for Domestic Violence / Dating Violence / Intimate Partner Violence in the medical setting SafeNet has counselor advocates on call 24/7 to meet with the victims in the medical setting. Victims are provided needs assessment, safety planning, and emergency referrals.

### **IPV and Traumatic Brain Injury, Strangulation, and Chronic Medical Conditions**

IPV can result in traumatic brain injury, symptoms of oxygen deprivation, chronic muscular pain or digestive problems, substance abuse, gynecological problems, and mental health concerns, including PTSD.

### **Effects of IPV on the Elderly and People with Disabilities**

When patients rely on the care of others due to limitations of age or physical/intellectual ability, they are vulnerable to abuse not only by partners but by family members and caregivers. They often fear disclosing abuse because of their reliance on assistance.

### **LGBTQ—IPV Does Not Discriminate**

With IPV rates similar to those in same-sex relationships, LGBTQ+ victims often face additional barriers to reporting abuse, seeking medical attention, and accessing IPV services.

### **The Complex Emotional and Psychological Effects of IPV on Children**

If children witness abuse at home, there is always more than one victim in the house. Without the support that helps build resiliency, children can carry the emotional, psychological, and physical effects of abuse well into adulthood. It can affect their future relationships and their success at parenting. SafeNet services can help.

### **IPV and Human Trafficking**

You have likely treated victims of labor or sexual trafficking. Learn definitions, statistics, and case histories of human trafficking and the importance of referrals for IPV services.

### **IPV in the Workplace**

The effects of IPV often follow victims to work. Recognize the signs that a coworker could be experiencing IPV and understand the potential health, safety, productivity, and financial implications. Workplace safety planning will also be discussed.

- Strengthening Families Program \* (814-455-1774 ext. 276 or [sgetz@safeneterie.org](mailto:sgetz@safeneterie.org)) SafeNet provides the Strengthening Families Program in all age ranges from Birth to age 16.

- Lethality Assessment Program LAP (814-455-1774 ext. 248 or [ryoung@safeneterie.org](mailto:ryoung@safeneterie.org)) SafeNet partners with the Pennsylvania Coalition Against Domestic Violence and multiple city and municipal and university police departments to provide this service. Police officers screen victims and make immediate referral calls to SafeNet for emergency safety planning. SafeNet and officers work together to encourage victims to go into SafeNet and receive services.
- Financial Empowerment (814-455-1774) ext. 248 or [ryoung@safeneterie.org](mailto:ryoung@safeneterie.org)) SafeNet counselor advocates provide financial empowerment classes through utilization of the All State Curriculum to encourage victims in their quest for autonomy and restoration.
- Transitional Living Program TLC (814-455-1774 ext. 276 or [sgetz@safeneterie.org](mailto:sgetz@safeneterie.org)) SafeNet provides services for homeless youth ages 16- 21 who are pregnant or parenting no more than 1 child. The goal of this program is to encourage homeless youth to participate in a program that offers a secure, stable environment for young parents and their children. Each parent is provided with an attractively furnished private room during their stay at TLC. Participation in the TLC Program offers residents the opportunity to focus on building a solid foundation for growth. Staff support helps to ease the transition to a new home, while increased awareness of available options and resources promotes independence.

Eligibility: Participants must be pregnant or parenting no more than 1 child and be in the age range of 16-21 and be willing to participate in group and individual learning experiences. This services does not require the person to be a victim of Domestic Violence/ Dating Violence / Intimate Partner Violence.

- 24/7 Hotline \*  
SafeNet provides a safe confidential hotline that is available 24/7 to all victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT. Services are provided by Counselor Advocates trained by the Pennsylvania Coalition Against Domestic Violence.
- Individual Counseling \*  
SafeNet provides individual counseling to all victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT. Services are provided by Counselor Advocates trained by the Pennsylvania Coalition Against Domestic Violence. These services are offered in person or virtually using tele-health. SafeNet provides interpretation services for victims who need American Sign Language (ASL) and for victims who are Limited English Proficient (LEP).

- **Group Counseling \***  
SafeNet provides group counseling that is available to all victims of Domestic Violence / Dating Violence / Intimate Partner Violence. Services are provided by Counselor Advocates trained by the Pennsylvania Coalition Against Domestic Violence. These services are offered in person or virtually using tele-health. SafeNet provides interpretation services for victims who need American Sign Language (ASL) and for victims who are Limited English Proficient (LEP).
- **Individual Advocacy \***  
SafeNet provides individual advocacy to victims when they are having difficulty accessing services necessary for their autonomy and restoration. Services are free and confidential and they are provided for all victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT
- **Systems Advocacy \***  
SafeNet works with systems to help provide referrals, options, and training for professionals in regards to Domestic Violence / Dating Violence / Intimate Partner Violence. Services are provided by Counselor Advocates trained by the Pennsylvania Coalition Against Domestic Violence. These services are offered in person or virtually using tele-health
- **Legal Advocacy and Accompaniment \***  
SafeNet provides legal advocacy and accompaniment to victims who are in need of a Protection From Abuse Order (PFA) or Protection from Sexual Violence or Intimidation Order (PSVI). SafeNet provides accompaniment to victims who are SafeNet Clients and are involved with the court system. This service is free and confidential and is provided to all victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT. Services are provided by Counselor Advocates trained by the Pennsylvania Coalition Against Domestic Violence
- **Emergency Shelter \***  
SafeNet provides emergency housing to all victims who are in need of housing due to Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT. All services are free and confidential. These services can be accessed 24/7. Services are provided by Counselor Advocates trained by the Pennsylvania Coalition Against Domestic Violence.
- **Bridge Housing \***  
Bridge housing is for victims who have additional barriers to finding safe housing. Bridge provides a program that helps victims work on removing barriers that keep them from traditional forms of housing. Bridge Housing is provided to victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT.

- **Mental Health Assessment and Referral \***  
Therapists help the client identify their presenting problems in relation to mental health, as well as identifying their strengths, weaknesses, resources and goals through the Transtheoretical Model. Therapists utilize the model of change to motivate clients in their readiness to change. This service is provided as needed to all victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT. All services are free and confidential. Services are provided by therapists who possess a MS, LPC, CADC.
- **Drug and Alcohol Assessment and Referral \***  
Therapists help the client identify their presenting problems in relation to drugs and alcohol, as well as identifying their strengths, weaknesses, resources and goals through the Transtheoretical Model. Therapists utilize the model of change to motivate clients in their readiness to change. This service is provided as needed to all victims of Domestic Violence / Dating Violence / Intimate Partner Violence regardless of age, race, or gender. SafeNet serves individuals who are cisgender and LGBT. All services are free and confidential. Services are provided by therapists who possess a MS, LPC, CADC.

**Description of Services:**

Safe Journey provides free and confidential services to all victims of domestic/dating violence. This includes individuals currently experiencing domestic violence and/or in crisis, and survivors who have experienced past domestic violence. Our services are comprehensive, trauma-informed, client-centered, and non-discriminatory. We also provide services to children, youth and teens, and have expanded our counseling/advocacy services to include video counseling and a chat feature on our websites.

**Individual Client Centered Services**

- **24-Hour Phone Hotline**  
Safe Journey provides a safe and confidential 24-hour hotline staffed by trained domestic violence counselor/advocates to provide advocacy and counseling to all domestic violence victims and significant other family members who are in crisis situations, currently living in domestic violence or have experienced it in the past.  
  
Eligibility: Victims/survivors of domestic/dating violence, their friends and family.
- **Individual Counseling**  
Safe Journey provides individual domestic violence counseling via telephone, at our main office, at Corry Counseling Services and other community sites throughout Erie County. In response to the Covid-19 pandemic, we have expanded our services to include telephone counseling, video counseling and chat features on all of our websites.  
  
Eligibility: Victims/survivors of domestic/dating violence.
- **Individual and Group Counseling for Children, Youth and Teens**  
Safe Journey's trained counselor/advocates provide individual and group counseling for children in families affected by domestic violence. All children who are, or have lived in domestic violence are deserving of trauma-informed support and education.

Eligibility: Individuals under the age of 18 who are or have lived in a family experiencing domestic violence.

- Emergency Shelter

Safe Journey provides up to 30 days of emergency shelter, which includes access to all other services provided by our agency.

Eligibility: Victims/survivors of domestic/dating violence.

- Assistance with (PFA) Protection From Abuse Orders

Safe Journey provides assistance with obtaining (PFA) Protection From Abuse orders; which includes support from trained domestic violence counselor/advocates in completing paperwork, court accompaniment and transportation as needed.

Eligibility: Victims/survivors of domestic and dating violence, family violence or teen dating violence.

- Custody and Child Support process assistance and referrals

Safe Journey has domestic violence counselor/advocates who provide accompaniment, support and advocacy to victims through the various processes regarding child custody and support.

Eligibility: Victims/survivors of domestic/dating violence.

- Safety Planning

Safe Journey has counselor/advocates trained in domestic violence who help victims assess risk of harm while in a domestic violence relationship, planning to leave or after leaving, by developing a holistic safety plan.

Eligibility: Victims/survivors of domestic/dating violence, their friends and family.

- Support Groups

Safe Journey provides daily domestic violence and empowerment support groups provided by trained domestic violence counselor/advocates who understand the value of listening to victims share their experiences of domestic violence. Victims are empowered by sharing their stories with other victims. In response to the Covid-19 pandemic, we have expanded our services to include online video support groups.

Eligibility: Victims/survivors of domestic/dating violence.

- Financial Assistance

Safe Journey may be able to assist clients with financial assistance regarding obtaining housing or relocation.

Eligibility: Victims/survivors of domestic/dating violence.

- Information and Referral Assistance

Safe Journey staff members are knowledgeable about a wide variety of resources in our communities that may be available for victims. Staff will assist victims as desired in self-referral, and support them through the often complex processes of successfully accessing those resources.

Eligibility: Victims/survivors of domestic/dating violence, their friends and family.

- **Support in Accessing Other Social Services**  
Safe Journey offers assistance in self-referral, accompaniment and transportation for other court and social services matters, including DPW, OCY, WIC, Social Security and Housing.

Eligibility: Victims/survivors of domestic/dating violence.

- **System Advocacy**  
Safe Journey works within various social systems to educate other provider agencies and entities regarding domestic/dating violence, and to advocate for what victims of all ages, races and genders need from these systems. Our counselor/advocates, trained by the Pennsylvania Coalition Against Domestic Violence, provide informational trainings on topics such as domestic violence dynamics and how to refer victims to Safe Journey domestic violence services. These services are offered in person or virtually using online video platforms.

- **Parenting After Domestic Violence Classes**  
These classes are led by trained domestic violence counselor/advocates and are designed to support and repair parent-child relationships damaged by domestic violence.

Eligibility: Parents who have experienced domestic/dating violence.

- **Family Advocacy Center**  
Safe Journey has a safe play space at our main facility where victims and their children can bond and strengthen relationships that have been impacted by domestic violence.

Eligibility: Victims/survivors of domestic violence and their children under the age of 18.

- **Financial Empowerment Counseling**  
Safe Journey's trained staff provides financial empowerment counseling classes that help victims achieve financial independence from their abusers.

Eligibility: Victims/survivors of domestic/dating violence

- **Informal Support**  
Safe Journey encourages survivors to stop by our facility at any time, chat with staff over a cup of coffee, share a meal, and enjoy social interaction and support from other survivors and staff. All clients also have access to the agency's laundry facility. Continued ongoing support promotes healing.

Eligibility: Victims/survivors of domestic/dating violence.

- Drug and Alcohol Safe Harbor Services provided at Safe Journey  
Safe Journey has partnered with UPMC Western Behavioral Health at Safe Harbor to provide their drug and alcohol services on site at Safe Journey. This service is available to victims of domestic/dating violence who are clients of Safe Journey.

Eligibility: Victims/survivors of domestic/dating violence.

### **Child and Teen Prevention Programs**

- Children and Youth Violence Prevention Education Programs  
Safe Journey's trained prevention educators provide a wide array of school-aged violence prevention programming for every grade level.

Eligibility: Children in preschool through 6th grade in rural Erie County.

- After School Prevention Programs  
Safe Journey's trained prevention educators provide after-school violence prevention activity programs.

Eligibility: Children, Youth and Teens in rural Erie County.

- Teen Dating Violence Prevention Programs  
Safe Journey's trained prevention educators provide teen dating violence prevention programming that addresses teen dating violence and healthy relationships for students in grades 6 through 12.

Eligibility: Youth of middle/high school age in rural Erie County.

- One-on-One Teen Dating Violence Counseling/Empowerment  
Safe Journey's teen counselor/advocates provide one-on-one counseling and empowerment support to help teens work through teen dating and domestic violence issues. Now available at the Corry and Union City school districts, we are working to expand into other rural districts.

Eligibility: Middle/high school-aged youth in rural Erie County.

### **Community Outreach**

- PurpleOne™ Training Program ([info@purpleone.org](mailto:info@purpleone.org))  
PurpleOne™ is a 4-hour domestic violence awareness and bystander training program designed to train individuals to recognize, respond and refer victims to free and confidential domestic violence services. A primary goal of the program is to bring victims to the PurpleOne website, where they can use the Safe Place Finder feature to identify local area Safe Places, public locations where

individuals who have received PurpleOne training are available to help them. Safe Places are businesses and agencies that have completed the PurpleOne training and are approved by Safe Journey to display a Certified PurpleOne Dot at visible locations outside their establishments.

PurpleOne provides training to all interested community businesses, companies, law enforcement agencies, social service providers, communities of faith, health care providers and others. PurpleOne is approved by the U.S. Office of Violence Against Women, and continuing education units are available through Northwest Tri-County Intermediate Unit 5 and the National Association of Social Workers-Pennsylvania.

- Dating/Domestic Violence and Healthy Relationships Presentations and Training in the College Setting.

Safe Journey offers dating/domestic violence and healthy relationships presentations and trainings (from one to three hours) for all college students.

Eligibility: Currently available at Edinboro University. Presentations and trainings are also available to any other local college or university upon request.

- One-on-One College Dating/Domestic Violence Counseling/Empowerment at area colleges.

Safe Journey has counselor/advocates available in the college setting to provide one-on-one counseling and empowerment support to help students work through dating/domestic violence and healthy relationship issues.

Eligibility: Currently available at Ghering Health Center at Edinboro University.

- Medical Advocate Program (MAP)

Safe Journey has a Medical Advocate available to provide training and assistance to health care providers in developing and implementing best practices and policies when responding to domestic violence. We provide information and ongoing assistance regarding screening, assessment, intervention and documentation.

Eligibility: Any health care provider or first responder.
